their questionnaires and send it back!



Over 325 Corporate, Board Members, and guests attended the ALPI's largest annual event. The theme for this year's event was "A Change Has Come: ALPI an Organizing Force for the Future." Mistress of Ceremonies for the luncheon was Dr. Barbara Kelly Bentley. Presentation of Colors was performed by the American Legion Post #201 of Winter Haven, FL. This year's musical selections were beautifully performed by Mr. Maxie Hunter and Ms. Carolyn Scott, both of Winter Haven, FL. Steven M. Hunicutt, City Commissioner of Winter Haven, FL extended greetings and Minister Michael Monfiston gave words of inspiration. ALPI Board Member, Mrs. Josephine Howard, gave a very warm

welcome to everyone and explained the significance of the occasion to all those gathered. ALPI Chief Executive Officer, Deloris Johnson, introduced the Keynote Speaker, Barbara S. Talley, a nationally renowned speaker, poet, author and publisher.

Mrs. Talley's moving message addressed the personal challenges she and many others have had to rise above in order to succeed in a very complex society. She noted that when the going gets tough, the tough learn new strategies. "We must unite, help others, demonstrate integrity, and demand excellence from ourselves and others if we are to survive individually and collectively." Learning to look for the lessons in adversity, character development, and an openness to consider different perspectives are just a few of the strategies she discussed for surviving in non-nurturing environments. Some of those strategies included channeling one's fear into productive action; considering different perspectives with an open mind; and, turning adversity into stepping stones. Mrs. Talley concluded by stressing the importance of vision, values, and virtues to one's own survival and personal growth.

The Schools and Libraries Program of the Universal Service Fund, commonly known as "E-Rate," is administered by the Universal Service Administrative Company (USAC) under the direction of the Federal Communications Commis-



sion (FCC), and provides discounts (via grants) to assist some schools and Head Start agencies in the United States obtain technology resources, equipment, software, professional development and other elements necessary to utilize connectivity. Since ALPI was awarded its second eRate Grant for telecommunications this past funding period, the Agency qualified to submit a Technology Plan and Grant Application for consideration. The Technology Plan filed by the Agricultural and Labor Program, Inc. (and approved by the State of Florida) was for a period of three-years (only 1 year is required).

ALPI has taken a proactive approach in the re-engineering of infrastructure for future requirements. Additionally, there must be strong connections between the proposed physical infrastructure of the information technology and the plan for professional development. The plan must have a professional development strategy to ensure that staff know how to use these new technologies to make overall improvements. This is constantly being worked on via email training, live training, and/or remote training.

Although ALPI's previous Wide-Area-Network was state-of-the-art when it was installed, this NEW completely re-engineered network system has been developed with "growth, speed, and efficiency" in mind. With large room to grow into, these new superior servers include two main HP ProLiant DL380 G6 series units, which will serve as the Main Server and Data Server. Three more of these same units will serve as terminal servers for staff outside of the Lake Alfred Administration Office.

Barracuda Backup Service has been deployed as an affordable, integrated local and offsite data backup and disaster recovery solution. Barracuda Web Firewall 310 has also been implemented and integrated, as well as Barracuda Antivirus/Anti-Spam software. Windows Server 2008, Exchange Server 2007, and Office Professional 2007 have been deployed on all the servers. ALPI anticipates upgrading to Version 2010 of all Microsoft products when it is released (Summer 2010).

All these upgrades and changes will help the Agency continue to move technologically forward in a business environment that is continually raising the bar and demanding more and more of Agencies that provide much needed critical services to those it serves in the local community.





SOUTHERN REGION 2009 continued the momentum gained in the previous year for the SRAC. Members attended the 2009 Annual Board/Policy Council Governance Training in Winter Haven, FL. SRAC also partnered with the Lakeview Park Homeowners Association in the delivery of both meals and indoor and outdoor recreational activities to approximately 100 young people via the Summer Youth Feeding

Program. Services were rendered by Council Members Katie Clarke and Betty Cobb, in addition to other community volunteers. The Southern Region Advisory Council

held it's Annual Membership Meeting on Saturday, October 31, 2009 in Frostproof, FL. The Guest Speaker was Gary Lewis (Raven Media Group), a native of the Frostproof community. The theme was "A Change Has

2010 Robert J. Bryant, Jr. Award

Congratulations to the ALPI's 2010 Robert J. Bryant, Jr. Award Recipient, Mr. William Holt.

This very prestigious award, which is named after longtime Board Member Robert J. Bryant, Jr., who passed away in 1990, is given to one member of the ALPI Board who exemplifies the leadership qualities displayed by Mr. Bryant during his tenure. Mr. Holt is the 21st recipient of the award, since it was first introduced in 1989.

William Holt was born in Port Gibson, Mississippi, one of 10 children (two sisters and seven brothers). He was raised in an era where radio was the primary means of communications. His family's three room home housed twelve people off and on. They had no bathtub and had to heat water on the top of the stove and place it in a tin tub. Clothes were washed in a big black pot, under which a fire burned. There were no inside bathrooms and practically no modern conveniences at all. Money was always short, but the family was extremely close and made due with what was available. William Holt became engaged in helping others because of his mother's compassion for those struggling and suffering in her community. By age 20 he was trying to make a difference in his own community by delivering food to the elderly, volunteering to paint homes for the elderly, assisting during emergencies by purchasing what he could for those in desperate need, etc. "My mother has always been my inspiration and my hero. It was her example that led me to have the heart of a volunteer. I take her favorite saying with me always ... don't shine your light, let your light shine!"

William Holt is currently Chairperson of the ALPI Board of Directors, Chairperson of the Florida Association for Community Action, Vice-Chairperson for the Florida Head Start Association, and Member of the Region IV Head Start Association. Past Chair positions include, but are not limited to, the Indian River County School Board Redistricting Board, Gifford Economic Development Board, and the Indian River County Black Caucus.


Mr. Holt's long history of community involvement and committment has resulted in many awards being bestowed upon him, including the Mississippi Black Businessman Award, Bethune Cookman Alumni Association Award, Democratic of the Year Award, FACA Volunteer of the Year Award, Florida Head Start Association - V.P. Award, and many others. He attended Alcorn State University, graduated from Webster University with a B.S. in Accounting and an A.S. in Computer Data Processing. He was drafted into the military, worked over 15 years as sales representative and manager at American General Insurance Company, and thereafter began working for Helseth Financal Mortgage Banking as a loan officer (he was later promoted to executive 2nd Vice President of Casino Investments). He is a member and Trustee of Mt. Zion Missionary Baptist Church.

William Holt has served on the ALPI Executive Board for many years. His support of the Agricultural and Labor Program, Inc. has remained constant, even in the face of great challenges and economic and political changes. Throughout the years his leadership skills and strength have helped guide the ALPI through some tough times and for this reason, among others, the ALPI is proud to award him the 2010 Robert J. Bryant, Jr. Award.
