Community Action ... A PROVEN COMMUNITY LIFE LINE ... 45 YEARS AND COUNTING

In 1964, The Great Society, as envisioned by President Lyndon Johnson, was a sweeping plan to improve the lives of all Americans, regardless of their circumstances. Some 45 years later and due to economic circumstances beyond the control of many low-come citizens, the CSBG funding that funds the Community Action Agency network programs and service delivery efforts continues to serve as a "Community Life Line" for many low-income children, families and rural communities.

In my opinion, a reduction in funding to the current CSBG service delivery network would be extremely detrimental to an already strained unemployment compensation market, the local Community Action Service delivery network, the small business network and other service delivery organizations that are collectively pooling limited resources to provide goods and services to address the needs of the nation's most vulnerable citizens, our low-income children and families. Rising costs for health care, housing, food, and utilities are only increasing the need for client services, thereby making any support reductions to the local Community Action Network unwise.

Community Action is an important safety net for many low-income individuals, children and families and we must "Do Whatever It Takes" to ensure that the Community Action Service Delivery Network remains intact to continue efforts to address the ongoing root effects of poverty and to, ultimately, move families and individuals toward self-sufficiency. 2011 Robert J. Bryant, Jr. Award

Marva Yvonne Hawkins & Josephine Howard

This very prestigious award, which is named after longtime Board Member Robert J. Bryant, Jr. (who passed away in 1990), is usually given to one member of the ALPI Board who exemplifies the leadership qualities displayed by Mr. Bryant during his tenure. This year however, the award has been given to two individuals who both possess these exemplary qualities: Marva Hawkins and Josephine Howard.



MARVA YVONNE HAWKINS was born September 24, 1936 in Sanford, Florida to Mr. Anderson D. Hawkins and Bessie Nutall Hawkins. She attended local public school and graduated from Crooms Academy in 1954. Ms. Hawkins also completed and attended Seminole County Vocational School. Further

education was received with emphasis on finances and accounting and in the medical field.

Ms. Hawkins was an agent for the American Life Insurance Company for 7 years and a community worker with the Seminole County Community Action, Inc. for 5 years. She also worked for the Seminole County Health Department and Seminole County Migrant Health Clinic for 11 years, was a State of Florida Foster Care/Children and Family Services Specialist for 12 years, and a correspondent for 45 years for the Sanford Herald Newspaper as a part-time columnist.

A long history of community involvement includes the following: Volunteer for the Supervisor of Elections, Volunteer and Office Manager for the Goldsboro Front Porch, Inc., State of Florida Governor's Project, Secretary/Treasurer for the Agricultural and Labor Program, Inc. (including Chairman of the Special Events Committee), Member of the City of Sanford Dr. Martin Luther King, Jr. Steering Committee, and Member of the Concerned Citizens Committee. Past member of the American Business Women Association (ABWA) and President of the Seminole African American Academy of Arts.

Honors bestowed upon Ms. Hawkins are numerous and include the following: Recipient of the International Black Women Congress-Central Florida Chapter Volunteer Award, Proclamation from Mayor Brady Lessard (City of Sanford) for Marva Hawkins Day, Heritage Jubliee Distinguished Service Award from the Black Faculty and the African American Cultural Forum (Seminole Community College), Certificate of Special Congressional Recognition for Outstanding and Invaluable Service to the Sanford Community from the Office of Congress of the United State - House of Representatives, Washington, D.C. (Corrine Brown, District Three), and Letter of Accomplishment and Gratitude for Years of Steadfast Commitment to Social Services from Jeb Bush, Governor of the State of Florida.



JOSEPHINE M. HOWARD is the oldest of six daughters born to the late Rev. Oscar McKnight and Mrs. Crizell H. McKnight in Orlando, Florida. She has been married to Phillip D. Howard, Sr. for 44 years and has two children and three grandchildren. Mrs. Howard holds three degrees: Florida Memorial College (St. Augustine, FL) - B.S. in Elementary Education (Cum Laude); University

of Central Florida (Orlando, FL) - Master's of Education (Magna Cum Laude); and, Nova University (Ft. Lauderdale, FL) – Education Specialist (Summa Cum Laude). She also completed further studies at the University of South Florida (Tampa, FL) – Certification in Administration and Supervision.

Mrs. Howard was employed by the Polk County School Board for almost 38 years, during which she served as: classroom teacher, Human Relations Specialist, Title I Reading Resource Teacher, Assistant Principal, and Principal. Following her retirement, Mrs. Howard opened her own business: Josephine Howard's Apparel.

In addition to running a successful apparel business, Mrs. Howard always manages to find time for community involvement. She currently holds the seat of Secretary on ALPI's Executive Committee and Board of Directors (she has served on the Board for 24 years). Additionally, she serves as Treasurer of the Horizon Housing Board, Financial Secretary of the National Coalition of 100 Black Women - Polk County Chapter, Inc., Secretary of the ALPI Central Region Advisory Council, Auxiliary Volunteer at the Heart of Florida Regional Medical Center, Member of the Polk County Minority Achievement Committee, and numerous other positions. She formerly served on the State Migrant and Seasonal Farmworkers Advisory Council, is a former member of the Toastmasters of the Villa and former member of the Heart of Florida Optimist Club.

Josephine Howard is a Lifetime Member of the NAACP #5150 in Haines City, Florida, where she is a member of the Board of Directors. She is a member of the FMU Alumni Association, recipient of the Dr. Martin Luther King, Jr. Lifetime Achievement Award, Polk County Teacher of the Year for Roosevelt School, recognized by the Elementary Guidance Counselors as Principal of the Year and recipient of the Progress Energy Efficiency Advocate Award.

Mrs. Howard has received many certificates, awards and other commendations during her lifetime. She is a public speaker and advocate for children and senior citizens. She is a people person and is always ready to roll up her sleeves and serve others.

Both recipients have served on the ALPI Executive Board for many years. Their dynamic and engaged participation, along with a sustained commitment to meeting community needs, have all served as an example to others of true activism. Ms. Hawkins and Mrs. Howard continue to demonstrate and utilize unique and creative approaches to help the ALPI develop and grow as a Community Action Agency. HIGHLIGHTS FROM ALPI'S Regional Advisory Councils

SOUTHERN REGION The Southern Region Advisory Council participated in the following Agency sponsored activities: Annual Corporate Meeting & Luncheon, Shared Governance Orientation, Its in Our Hands Census Count, Annual Family Picnic, and 1st Florida Symposium on Poverty. Services provided in the Council's service areas of Avon Park, Bowling Green, Frostproof, Lake Placid, Sebring, Wauchula, and Zolfo Springs included: Summer jobs provided to five youth to assist with the Summer Discovery and Summer Feeding Programs; LIHEAP and CSBG assistance provided to 2,242 clients; Head Start services to 54 clients; and Early Head Start Services to 39 clients. The Council partnered with the ALPI CSBG Department in delivering meals via the Summer Youth Feeding Program and indoor and outdoor recreational activities via the Youth Discovery Program to approximately 100 youth. The SRAC ended its year with the distribution of ten holiday

gift cards to needy families in the local surrounding communities. Officers elected: Terry Wellington, Chairperson; Katie Clarke, Vice Chairperson; Annie Robinson, Secretary; and Sharonda Dunlap, Treasurer.

EASTERN REGION The Eastern Region Advisory Council focused on the Scholarship Program as its major project for this year. Applications were received and screened by the Advisory Council Scholarship Committee and a selection was made. The scholarship award amount is \$500.00 and is named for the Late Arie L. Ms. Perkins was employed by ALPI for a number of years as Director of the ALPI Indiantown Child Development Center and the Thelma Waters Infant Care Center serving the Booker Park Community in Indiantown. The Advisory Council Annual Meeting Luncheon was held on October 16, 2010 in Ft. Pierce. The Theme for the meeting was "Reflecting on the Past ... Moving Through the Present ... and Molding Our Children for the Future". Queen Townsend, retired Assistant Superintendent of St. Lucie County School Board, was the speaker. The election process was facilitated by staff liaison. Corporate members were identified, ballots were handed out, and the membership voting was completed. The membership roster is on file at ALPI Corporate Office. The highlight of the day was the Advisory Council's recognition of the late Mary Jones, Head Start Director. Ms. Jones was recognized for her outstanding service in the position of Head Start Director for more than 30 years. The awards were facilitated by Marjorie Gaskin and Bobby Byrd. Commissioner Reginald B. Sessions received the Council's Community Service Award for outstanding support to the ALPI Eastern Region Advisory Council. NORTHERN REGION The ALPI Technical Education Center (ATEC) continues to be licensed by the Florida Commission for Independent Education (CIE) for the provision of occupational training in Volusia County. In 2010 Home Health Aide and Phlebotomy were added to the curriculum, which includes Nursing Assistant. Two Nursing Assistant classes were offered, with a total combined of 23 students in attendance. Three Home Health Aide classes and one Phlebotomy class were also offered. ATEC is also a training facility for the provision of CNA test preparation. Additionally, the facility has internet access and a bank of six computers which allow clients, students, and the local community to apply for services with other agencies and conducting job searches. As a member of the PSP (Partner Support Program) for the United States CENSUS 2010, the Council provided outreach in their local communities reaching out to the Hard To Count (HTC) population. Approximately 500 Census t-shirts were distributed in 7 Cities, including Orlando. The Council also partnered with the Phi Beta Sigma Fraternity to distribute ninety Thanksgiving baskets to low-income families in the community Altogether, the Council volunteered over 17,000 hours. Officers elected: Evelyn Seabrook, Chairperson; Donald Tillman, Vice-Chairperson; Constance Anderson, Secretary; Marva Hawkins, Treasurer; Sylvia Bodison, Special Events Coordinator; and, Charles Harris, Parliamentarian.

After graduating from Central High School with honors, Dr. Hill continued his education at the Detroit College of Business and Golden Pacific University where he earned his Master's Degree in Business Administration. While he was working on his education he was also employed at the Children's Hospital in Detroit, MI. During his seven year tenure there, Dr. Hill rose from Maintenance to Admittance then on to the Credit Department. He later received a Master's and Doctoral Degree of Divinity

from Friends International University.

During his career, Dr. Hill has collaborated and performed with a variety of national recording artists. He is the Founder/Director of Youth On The Move, USA, Inc. and Life Without Limits International, Inc. as well as the CEO of Vision Productions and Publishing
