### **HEAD START WORKS!**

In January of 1964, President Lyndon B. Johnson declared The War on Poverty in his State of the Union speech. In the summers of 1965 and 1966, the *Office of Economic Opportunity* launched the eight-week Project Head Start.

I began my journey with the head start movement as a teacher in a classroom of 80 plus energetic pre-school age disadvantaged children. The opportunity was made available via the Palm Beach County Rosenwald Elementary School located in South Bay, FL.

In the summer of 1971 I was given another opportunity to work with Migrant and Seasonal Farmworker Children and Families via the Community Action Migrant Program (CAMP) Head Start Program for a period of seven years. This was an experience that propelled me to another level of the Head Start movement including, program planning, management, national head start professional development, monitoring and advocacy opportunities.

I am proud to have been a part of the original players in the making of a federally funded program that has a proven track record and more positive outcomes than not in the provision of comprehensive early childhood education, health, nutrition, and parent involvement services to lowincome children and their families.

Some 50 years later and based on my direct involvement and experiences, I can say without any reservations that HEAD START WORKS! I encourage all who are currently involved to continue to move forward to ensure that the same opportunity is available for many more years and to ensure that all children in need are provided ... A HEAD START.

# CAMP READY 2014



Camp Ready 2014 was hosted, for the fourth year, at the Frostproof Child Development Center in Frostproof, Florida. Camp ran from June 9th through July 3rd, 2014. This program was a collaborative effort between ALPI and the Learning Resources Center. The objective of the collaboration was to work together to provide an opportunity for preschoolers entering kindergarten to have an extended school year of activities geared toward preparing them for kindergarten. The goal of the program was to assist children to enter kindergarten "ready to learn", while enhancing skills with remedial activities to successfully transition to kindergarten. Parent engagement was also fostered in the program through volunteering in the classroom, weekly family take home activities, and child outcome reports at the start and end of the program. Breakfast, lunch, and a snack were provided daily to the more than 30 children participating in the program. Instructional staff were provided by the Learning Resources Center and were certified kindergarten teachers from the local public school.

This summer, ALPI partnered once again with the Polk County School Board in order to provide services to the community of Frostproof, FL through the ALPI

Summer Feeding Program. The program was operated from ALPI's Lakeview Community Center in Frostproof, FL and lasted from June 11th through August 1th, 2014. Temporary summer employment was also made available for qualified

youth. The program was able to serve an average of 75 -80 meals daily to children in the community between the ages of 1 and 18 years of age. The program not only provided meals, but also fun, educational, age appropriate activities coordinated by ALPI Child Development Services staff.

# **AUGUST ENERGY FAIR**



Of the more than 700 people waiting in line on August 14, 2014 at the Winter Haven Recreational & Cultural Center for assistance with paying their electric bills, an incredible 463 received help onsite! This is a record for the ALPI LIHEAP

Department. Almost 300 more received assistance within the following two weeks.

A very long line of people streamed down Avenue T and through a residential street, causing traffic jams. With temperatures exceeding 90 degrees, people patiently endured the heat and later on the rain, in hope of getting their electric bills paid.


People began arriving as early as 4 a.m., even though the doors of the center did not open until 10 a.m.

Residents of Polk County were referred to the Energy Fair by Agricultural and Labor Program Inc., which offers the Low Income Home Energy Assistance Program (LIHEAP). The event was sponsored by the program and Access Florida, the Florida Department of Children and Families' Automated Community Connection to Economic Self Sufficiency.

LIHEAP is designed to assist with funds to help with home energy bills, help in an energy crisis or help with weatherization and energy-related minor home repairs. "The program is designed to help keep families safe and healthy," said ALPI Program Director Cheryl Burnham. Mrs. Burnham, together with a highly experienced group of ALPI staff and dedicated volunteers, managed the crowd through the entire process.

Other local organizations represented at the event included, but were not limited to, the Social Security Administration, Catholic Charities of Central Florida, East Central Polk Democratic Club, and Florida Department of Children & Families Refugee Services Program, New Beginnings High School and Central Florida Health Care.

After completing the paperwork and providing documentation of their needs, each applicant was given a card to have each agency



# ALPI Client Receives Prestigious SEACAA Award




ALPI's Work Experience Program client, Rafael Cruz, was recently presented with the Lonnie D. Burton Achievement Award in September at the SEACA 2014 Annual Conference, held in Biloxi, MS. This award is presented annually by the Southeastern Association of Community Action

Agencies (SEACA) to an individual who, through the assistance of a Community Action Program, has achieved a significant level of self-sufficiency and independence, while recognition is given to the local Community Action Agency's role in helping the nominee(s) to help themselves.

Through a partnership with the Avon Park Housing Authority and because of an immediate need for contracting of a lawn care company, an amazing opportunity became available to Rafael Cruz. Although he did have access to some lawn maintenance equipment, he did not have enough money to hire an employee to jump start the new business. ALPI then stepped in and assigned this second job opportunity to another Work Experience Program participant. Rafael was then referred to the Small Business Association for training and was later referred to Habitat for Humanity. Using income from his new business, he began working to correct credit issues that might block a mortgage and, along with his family, began

to put in "sweat equity" as Habitat for Humanity volunteers, helping others build homes. Their dream of owning their own home finally became a reality on January 23, 2014. Less than a year ago, Rafael Cruz and his family (pictured right) identified themselves as homeless ... today they are proud homeowners.

Career Center. Through assistance from ALPI's FSSP, she was able to reach her goals and rise to the top of her class.


