# **ALPI'S NEW PARTNERSHIP:**

ALPI is proud to announce its new partnership with Tampa's Senior Connection Center, Inc. (SCC) in administering the Polk County Emergency Home Energy Assistance for the Elderly Program (EHEAP). As a result of Polk County no longer administering the EHEAP program as of March 31, 2015, ALPI was specifically selected as a possible administering agency, especially in light of ALPI already administering the LIHEAP program. After much consideration, and with ALPI

Board's approval, ALPI officially became the administering agency for the EHEAP program in Polk County, Florida on April 1, 2015.

The Emergency

Home Energy Assistance for the Elderly Program (EHEAP) assists low-income households that include at least one person aged 60 or older when the households experience a home energy emergency. This program is 100-percent federally funded by the U.S. Department of Health and Human Services. EHEAP is a component of the

federally funded Low-Income Home Energy Assistance Program (LIHEAP), which is administered by the Florida Department of Economic Opportunity.


Payments are for home heating or cooling and other emergency energy-

> related costs during the heating (October-March) and cooling (April-September) seasons. Eligible households may be provided

one benefit per season. The maximum crisis benefit is \$600.00 per household per season. Payments are made directly to the vendor for electricity, natural gas, propane, fuel oil, kerosene, or wood.

Rosa Mae Thomas (66 years old from Lakeland, FL) received a disconnect notice of May 18th on her light bill of \$100. Due to unexpected expenses, she couldn't afford to pay this bill. With assistance from ALPI's EHEAP program, her bill was fully paid and an electrical disconnect was prevented!

Program beneficiaries may receive vouchers to purchase blankets, portable heaters, and fans. The program can also help pay for repairs to existing heating or cooling equipment or for energy-related utility reconnection fees.

#### TO BE ELIGIBLE FOR ASSIS-TANCE, HOUSEHOLDS MUST HAVE THE FOLLOWING:

- A heating or cooling home energy emergency
- At least one individual age 60 or older in the home; and
- A gross household annual income of no more than 150% of the federal poverty guidelines

## ANOTHER SUCCESSFUL YEAR



This summer, ALPI partnered once again with the Polk County School Board in order to provide services to the community of Frostproof through the ALPI Summer Feeding Program. The program was operated from ALPI's Lakeview Community Center in Frostproof and lasted from June 11 through July 31, 2015. Temporary summer employment was also made available for qualified youth. The program was able to serve an average of 75-80 meals daily to school age children in the community. The program not only provided meals, but also fun, educational, age appropriate activities coordinated by ALPI Child Development Services staff.

## Early Learning Coalition of St. Lucie County 9<sup>th</sup>Annual Family Fun Fair


